Child & Family Center

Child & Family Center provides mental health, behavioral and education services to children, adults and families in the Santa Clarita Valley. The year 2006 marked the Center's 30th anniversary.

A variety of programs help children from infancy to adulthood, deal with



various emotional and behavioral problems including aggression, depression, drug and alcohol abuse or hyperactivity. Currently 550 children are helped every week.

The Center's staff of professionals includes child psychiatrists, licensed psychologists, licensed clinical social workers, case managers, and preschool teachers who work together as a team, assuring the best treatment approach for every child and family. All of the programs involve interaction with family members to encourage nurturing relationships in the home.

One of the Center's most innovative programs is the School Based Counseling Program, which provides therapists on school campuses. The program is very effective, as it allows a child to be seen when a problem is first developing and can prevent problems from escalating into more serious ones.

In addition, children can be seen during school hours, alleviating transportation issues or the stigma associated with coming to a mental health clinic.

Currently, 26 campuses throughout the Santa Clarita Valley are served, with the goal to provide a therapist on every campus in the valley.
